HOW TO USE

- 1) Hold the  button for 1.5 seconds until the light turns on: the motor enters the standby mode.
- 2) When in the standby mode, press the remote  button to enter the memory mode and click again to switch to the start function.
- 3) Press the  button to turn on the work mode, including weak, medium, and strong + 7 vibration edge modes (10 vibration modes).
- 4) Press the  button. Any mode can go into the burst function, and the function will be switched off automatically 10 seconds later. You can press the  button to switch it off immediately, and go to the previous setting.
- 5) Hold the  button for 1.5 seconds to turn the device off.

CHARGING

USB Pin Charging.

- 1) Completely dry the toy before charging.
- 2) When the toy is charging, the light will flash. The light will always be on when the device is fully charged.
- 3) Only use the original charger provided with the toy when charging.
- 4) Disconnect the charger once the toy is fully charged. Do not leave the charger connected if the toy is fully charged. **KEEPING THE CHARGER CONNECTED WHEN TOY IS FULLY CHARGED MAY CREATE A FIRE HAZARD.** Keep the charger away from metal items.
- 5) Do not use the toy when it is charging.

CLEANING AND STORAGE

- 1) Always clean the toy before and after each use.
- 2) ONLY use a toy cleaner specifically formulated to clean and sanitize adult toy products. After cleaning, rinse with warm water before use.

- 4) This product is NOT dishwasher safe. Do NOT place it in a dishwasher, washing machine, dryer or similar appliance.
- 5) Store the toy in a cool, dry place.
